## **BAIL BOND CONTRACT and AGREEMENT**

I, \_\_\_\_\_, **Defendant/Principle**, hereby agree to the following terms and conditions in consideration for A-1 DISCOUNT Bail Bonds /Bail Bonds and its agents acting as **Surety** on my bond:

1. To **APPEAR IN COURT** on all dates indicated by A-1 DISCOUNT Bail Bonds, my attorney, the Court, or clerk of the Court for any and all courts where I have a case or cases pending. I understand that I am "on bond" until all of my cases are disposed of, meaning that I have received a dismissal or a judgment which has been signed by a judge, filed with the clerk, and a copy given to my bail bond company and the bail bond is released by Montgomery County, Texas.
2. To **CHECK IN** with my bail bond company **ONCE A WEEK (TUESDAY OR WEDNESDAY) UNTIL ALL CASES HAVE BEEN RESOLVED. THERE ARE SEVERAL METHODS AVAILABLE FOR YOU TO CHECK IN:**

3. To **REPORT ANY CHANGES** in address, telephone number, employment, or attorney to A1 DISCOUNT Bail Bonds..
4. To **PAY** as agreed in the attached "Payment Agreement." (if applicable)
5. **To NOTIFY A-1 DISCOUNT BAIL BONDS within 24 HOURS if ARRESTED.**  
I authorize A-1 Discount Bail Bonds to post my bond in the event of a subsequent arrest prior to the notification above.

I understand that failure to comply with any of these requirements may result in A-1 DISCOUNT Bail Bonds filing an Affidavit of Surety to Surrender, which will result in a warrant being issued for my arrest. I also understand that if this occurs, no fees, premiums, cash deposits or collateral are refundable.

I understand that if I fail to comply with any portion of this agreement, any and all legal remedies available by law will be pursued against both me and the person who signed as my Indemnitor/CoSigner.

I understand that **BAIL JUMPING** is an offense punishable by law.

### **Service Agreement**

I further agree that in the event I fail to appear in any court that this Surety Company has bonds outstanding in, the cosigner will pay the Surety, in certified funds, the face value of all bonds forfeited plus the cost of court for each bond within 10 days of the failure to appear date.

In addition, the Cosigner, shall be responsible for a retainer

**I understand that this bond is for a TWELVE MONTH (ONE YEAR) period.**

If my case continues **BEYOND ONE YEAR** from the date of the bond,  
A1 Bail Bonds/Bail Bonds for Less has the option of charging a **RENEWAL FEE**.

**I UNDERSTAND THAT IF I FAIL TO CHECK IN FOR MORE THAN TWO WEEKS IN A ROW, A \$29.99 FEE WILL BE CHARGED TO MY ACCOUNT. IF ANY LEGAL PROCESS IS INIATED DUE TO FAILURE TO CHECK IN, A MINIMUM FEE OF \$75 WILL BE CHARGED, IN ADDITION TO THE \$29.99 LATE FEE**
